FEE ELIGIBILITY - for all dogs aged 6 months or older at 1 July 2024, all fees must be paid in full by 31 July 2024. In the case of a dog passing the age of 6 months after 30 June 2024, fees must be paid by the end of the calendar month in which the dog reaches that age.

NEW DOGS - dogs must be registered within 14 days after you acquire the dog.

CONCESSION/HEALTH CARE CARD HOLDERS - you must produce a Commonwealth Pensioner Concession Card, Repatriation Health Card or Health Care Card.

DE-SEXED DOGS - you must produce a veterinarian's certificate of de-sexing at the time of initial registration to qualify for the discount.

SPECIAL ASSISTANCE DOGS - you must produce evidence that the dog has been trained by an organisation for the specific purpose of performing identifiable physical tasks and behaviours to assist a person with a disability, in order to aid quality of life and/or independence.
